

## Terms and Conditions – Player Worn Warm-Up T-Shirt Silent Auction

**Organiser:** TFC AFL Limited ("we", "us", "our") **Platform:** This auction is hosted via Zeffy located [here](#). **Beneficiaries:** 100% of net proceeds raised will be donated in equal shares between:

- Lifeline Australia
- Headspace

*(Distribution will occur after the auction closes and all payments have cleared. Net proceeds means gross auction proceeds less any unavoidable costs directly attributable to running the auction).*

### 1. About This Auction

1.1 This is a silent auction of player-worn Warm-Up t-shirts, organised by TFC AFL Limited to raise funds for the charities listed above.

1.2 The auction opens **Friday 10 July at 4:30pm AEST** and closes **Saturday 11 July at 4:30pm AEST**. We reserve the right to extend, shorten, or cancel the auction, or withdraw any item, at our discretion, including due to technical issues with the Zeffy platform.

1.3 By placing a bid, you agree to be bound by these Terms and Conditions.

### 2. Eligibility

2.1 You must be 18 years or older to bid.

2.2 Bids must be placed by the bidder in their own name. Bidding on behalf of another person without their knowledge, or using a false name, is not permitted.

2.3 We reserve the right to refuse or cancel any bid at our discretion, including where we reasonably suspect fraudulent, collusive, or fake bidding activity.

### 3. How Bidding Works

3.1 All bids are placed through the Zeffy platform at the link provided. Starting bids and any bid increments are set individually for each item listing on Zeffy.

3.2 The highest valid bid recorded on Zeffy at the close of the auction wins that item. All sales are final — bids cannot be withdrawn or amended once submitted.

3.3 We are not responsible for bids that fail to register due to internet connectivity issues, device problems, or platform outages.

## 4. Payment

4.1 Payment is processed securely through Zeffy at the time of your winning bid (or as otherwise instructed by us), in Australian dollars (AUD).

4.2 Zeffy does not charge our organisation any platform or transaction fees for this auction, all bid proceeds go toward the auction and our beneficiary charities. At checkout, Zeffy may invite you to leave an optional, separate tip to Zeffy itself — this is entirely voluntary and has no bearing on your winning bid or the funds raised for our charities.

4.3 Payment for your winning bid is completed at checkout through Zeffy. If you require postage, payment for postage must be completed no later than **Saturday 18 July**. If postage payment is not received by this date, we reserve the right to cancel the sale and offer the item to the next highest bidder.

## 5. Item Condition and Description

5.1 All items offered are **player-worn** Warm-Up t-shirts and are sold as used, second-hand memorabilia. Items may show signs of wear consistent with genuine use, including marks, stretching, or minor damage. Photos and descriptions on the listing are provided as a fair representation, but we do not guarantee an item's condition beyond what is described.

5.2 We will make reasonable efforts to describe the player and match/event associated with each item where known, but we do not warrant match-worn provenance beyond information provided to us and cannot guarantee items are free of defects.

5.3 As these are used, one-of-a-kind charity items, **all sales are final**. Due to the nature of the items (used and unique), no returns, exchanges, or refunds will be offered except where required by Australian Consumer Law (for example, if an item is not as described in a material respect).

## 6. Collection and Delivery

6.1 Winning bidders may choose to: (a) collect their item in person from **the Devils Den, 144 Collins Street**, open **Monday–Friday, 10am–4pm**; or (b) have their item posted to an Australian address, with postage paid by the winning bidder at cost.

6.2 Items will be available for in-store collection from **Monday 13 July**. If posting, please call us on **6159 8888** to arrange and pay for postage — payment for postage must be completed no later than **Saturday 18 July**, and posted items will be dispatched from **Monday 20 July**.

6.3 We are not responsible for items lost or damaged in transit once dispatched via a tracked postage service, though we will assist in lodging any claim with the courier where reasonable.

## 7. Tax and Receipts

7.1 Because winning bidders receive goods (a t-shirt) in exchange for their payment, **bid payments are not tax-deductible donations**. This auction is a fundraising sale, not a gift, for taxation purposes.

7.2 We are not a registered charity ourselves; we are raising funds on behalf of the three beneficiary charities listed above, to whom net proceeds will be forwarded after the auction concludes.

7.3 If you would like to make a separate, tax-deductible donation directly to any of the beneficiary charities, you're welcome to do so via their own donation pages (linked above); such donations are subject to those charities' own terms and receipting practices, not ours.

## 8. Use of Player and Club Imagery

8.1 Any player names, club logos, or team imagery referenced in this auction are used for the purpose of identifying and describing the item honestly, and remain the property of their respective owners (e.g. the AFL, clubs, or players). This auction is a charitable fundraiser and is not an official or endorsed AFL/club product unless expressly stated.

## 9. Privacy

9.1 Personal information collected during the auction (such as name, email, address, and payment details) is collected and processed via Zeffy's platform in accordance with Zeffy's own privacy policy, and will only be used by us to administer the auction, contact winners, and arrange delivery.

## 10. Liability

10.1 To the maximum extent permitted by law, TFC AFL Limited excludes all liability for any loss or damage arising from participation in this auction, except for liability that cannot be excluded under Australian Consumer Law.

10.2 Nothing in these terms limits any rights you have under the Australian Consumer Law that cannot lawfully be excluded.

## 11. Governing Law

11.1 These terms are governed by the laws of Tasmania, Australia.
